## MISSION CRITICAL: PROTECT & SERVE Insight Into Challenges

#### **CHILD ABUSE**

- More than 600,000 children are abused in the U.S each year <u>www.nationalchildrensalliance.org</u>
- www.macrotrends.net1,750 children died of abuse and neglect in the United States www.cdc.gov

#### **CRIMES AGAINST PROPERTY**

- Burglaries steadily decreased in the USA and Boone County showed a 16% decrease.
- Thefts in the USA showed a slight increase and Boone County showed a 11% decrease.
- The average drunk driver has driven drunk 80 times before their first arrest (Madd.org).
- 90% of child sexual abuse victims know the perpetrator in some way. 68% are abused by a family member <u>www.childprotect.org/</u>
- In 2019 Indiana had the second highest rate of child abuse in the nation
- Total Child Abuse case reports in Boone County increased from 67 (2022) to 84 (2023).

#### ALCOHOL and DRUG ABUSE

#### CRASHES

- Although the U.S. population has continued to grow since 1975, the rate of crash deaths per 100,000 people in 2021 was 39 percent lower than it was four decades ago <u>www.iihs.org</u>
- In 2021, the percentage of crash deaths involving speeding was higher on minor roads (33 percent) than on interstates and freeways (29 percent) or on other major roads (26 percent) www.iihs.org

- Traffic fatalities are down across the state and Boone County has a 43% reduction at this time
- BCSO crash reports decreased from 777 (2022) to 565 (2023).

#### **ENFORCEMENT**

#### **ENFORCEMENT**

Units, Peer Support Team, & Bicycle Patrol.





## GOAL 1 Proactive Enforcement

#### **CRASH PREVENTION**

Traffic enforcement is a key strategy to help reduce crashes in Boone County. The most common cause of crashes: following too closely. Additional traffic enforcement was emphasized in areas with a high volume of crashes.

The Boone County Sheriff's Office is responsible for many heavily traveled roadways and intersections. In 2023, data compiled showed 690 crashes. Four of those were fatal crashes with four fatalities total in 2023. Specifically, 134 crashes resulted in personal injuries.



#### **CRASH TEAM**

The BCSO FACT Team investigates vehicle collisions involving serious bodily injury or death. They utilize specialized tools and software to accurately reconstruct the scene.

#### **CIVIL SERVICE**

Retired Captain Jeff Keller serves papers such as summons, subpoenas, eviction orders, protective orders and notices to appear for agencies in and out of the state. These critical components help our community thrive.



#### **COURT SECURITY**



Courthouse Deputies vigilant attentiveness was once again imperative in 2023. The staff is led by Sergeant AJ Naekel and has 5 assigned

deputies.





#### **HUMAN TRAFFICKING**

Human trafficking is a rapidly growing crime in Indiana as well as the United States. Each year, the number of identified cases in Indiana rises as awareness and education increases across the state. While there is currently no unified state database for human trafficking statistics in Indiana, 123 cases involving 176 victims were identified in Indiana through the National Human Trafficking Hotline in 2021 alone. #### **CAR SEAT INSPECTIONS**

The Support Division helped keep children from birth to age 8 safe by hosting a National Child Passenger Safety Certification Training Program. Seventeen technicians successfully completed the course. Ten families visited BCSO to seek assistance and eight car seats were replaced.

Remember all children under the age of 8 must be properly restrained in a child safety seat or booster. Children under 1 year and less than 20lbs must face the rear of the vehicle. To request a car seat inspection call: **317-482-1412.**

Car Crashes are a Leading Cause of Death for Children Ages 1-13.

Encourage rear facing car seats up to the age of 2 or as long as the seat fits the child by the height & weight requirements.

#### **BODY CAMERAS**

BCSO continued a body camera program. As part of the program, deputies within the Boone County Sheriff's Office are using the Utility intelligent **body cam** technology on service calls across all shifts. The body cam cameras are durable high-definition cameras worn on the front of deputy's uniforms that are Wi-Fi, Bluetooth, and GPS-enabled. The unit uploads the video and audio captured to a secure cloud-based site where videos can be reviewed by deputies and administration.

#### WARRANT SWEEPS

The Sheriff's Support Division managed all the records related to warrants in Boone County. Correctional Officers processed the warrants, while patrol deputies focused on serving as many warrants as possible to help keep fugitives off the streets.

#### **CRIMINAL INTELLIGENCE UNIT (CIU)**

Eight uniformed deputies and a detective worked as a small, but proactive unit within the Investigations Division to help reduce crime. This unit focused its efforts to target any help reduce crime. This unit focused its efforts to target any criminal element in Boone County. They assisted with drug investigations, serving warrants, and generating intelligence.





#### **BICYCLE PATROL**

Boone County is proud to have the Big 4 Rail Trail and the Sheriff's Office wants it to remain safe for family recreation. BCSO routinely can be seen on bike patrols or ATV patrols on the trail. In addition, we attend many festivals to aid local agencies.







#### **ANIMAL CONTROL**

Our Animal Control Division continues to be an asset to those communities in Boone County struggling with animal complaints. The county has received over 300 animal complaints this year.

#### **BATTLE OF THE BARBEQUE**

The Boone County Cancer Society hosts an annual event that raises awareness for cancer patients battling the disease. In 2023, the Boone County Cancer Society hosted its 16th annual Battle of the BBQ! It was a HUGE success. They raised

over \$99,000 with about 40 sponsors and in-kind sponsors. They had 30 teams come and cooked for over 2,000 people. Each year the BCSO team gathers a team to compete in the event. Over the years our team has won several awards for our entries.

#### **SOCIAL MEDIA**

The Boone County Sheriff's Office had a strong social media presence in 2023. The timely press releases or notification of public incidents increased our ability to communicate. BCSO will continue to expand our outreach to include employee spotlights and other agency activities.





#### **BOONE COUNTY SENIOR SERVICES OLYMPICS**



Boone County Senior Services was founded in 1978 and continues to serve and educate seniors on life's changes that affect them. One of the great events that occurs once a year is the Olympics. This event engages seniors of all ages in sporting events that pit them against others in their age group. Whether it be running, throwing, or playing games, the BCSO staff has been involved for many years in assisting and cheering on the seniors.

#### PARADES AND FESTIVALS

The BCSO staff participates in many parades and festivals throughout the year. From the annual Lebanon 4<sup>th</sup> of July parade to the many fall festivals that occur across the county, BCSO is well represented. Staff and their families from across divisions hand out candy, walk the parade routes, and tend to our booth during these events. These events promote community pride and BCSO wants to show our dedication and support for all communities in Boone County.



#### **SCHOOL PARTNERS & PARTICIPATION**

The Sheriff's Office assigned 7 full time SROs (Student Resource Officers) to the Western Boone Community Schools and the Zionsville Community Schools. The SRO program is led by Sergeant Neil Randolph and includes Deputies Jesse Boggs, Tony Bayles, Ken Conley, Cary Clanton, Bob Anderson, Marc Mitalski, and Cameron Thomas.

#### **HIGH SCHOOL CAREER OPPORTUNITIES**

The Sheriff's Office began taking advantage of the many programs being offered at area high schools with their career development programs. One of the programs that we are using is the West Central Indiana Career and Technical Education program. The program centers around ensuring an education system of high quality and equity for academic achievement and career preparation for students. Through the program BCSO has been able to hire students directly from high school and into positions within our agency.



#### **YOUTH SUMMER CAMPS**

The Boone County Sheriff's Office partnered with the City of Lebanon Fire Department to offer a 5-day camp that showcases many police and fire skills, along with life skills to help campers in their daily lives. Campers get to experience an obstacle course, shoot simunitions and make mock traffic stops.



#### INDIANA SHERIFFS' ASSOCIATION YOUTH LEADERSHIP CAMP

The camp celebrated its 41st year in 2023. The program is designed to achieve three basic objectives. First, the deputies want to foster a stronger relationship between our state's youth and the men and women who enforce the laws. Second, the deputies want to give children, who ordinarily would not have the opportunity, a chance for a summer camp experience. The third goal is to give youth a chance to build character and inspire leadership skills.





#### **CITIZENS GUN CLASSES**

The Boone County Sheriff's Office Firearms Division led by Major Brian Stevenson and Lieutenant Craig Fouts, offers citizens from across Boone County and Central Indiana the opportunity to take certified gun training classes. Both instructors possess a vast knowledge of tactics and an overall mindset that will enable citizens to obtain training to be a responsible and skilled gun owner.

#### V150 RIDES

The United States Military instituted a loaner program years ago that allowed local agencies across the country to utilize surplus military vehicles for use in department activities. BCSO was fortunate to obtain the 4x4



amphibious vehicle to use in Special Response Team emergencies. When not being utilized for call outs, the vehicle is used to transport school children to

school that have won a chance from raffles at charity events. Many school PTOs and other fundraising organizations contact our staff to give students rides to school.



#### **POLICE WEEK**

Each year Law Enforcement agencies from across the country descend upon Washington DC to the National

Police Memorial to pay their respects to those officers that have lost their lives in the line of duty. Regionally and locally, many jurisdictions have their own tributes. The BCSO, along with other countywide agencies, is no different and we celebrate our fallen officers each year at a ceremony on the grounds of the Boone County Courthouse.





#### **CRIME TIPS**

The Investigation Division followed up on all crime tips. Captain Jason Reynolds leads the division, which is composed of two general case detectives, two crime scene investigators (CSI), one media specialist, three task force officers (TFOs), and a sex offender registrar. The division also encompasses the Criminal Intelligence Unit (CIU), which is comprised of eight uniformed deputies, a sergeant, and a K-9. Their fundamental strength is based on the general public being cognizant and aware of their surroundings to report suspicious activity.

#### 1. APPLY ONLINE

Complete an application online at https://firearms.ariesportal.com

#### 2. SCAN FINGERPRINTS

Schedule an appointment online to have your fingerprints electronically scanned at a convenient <u>IdentoGO location</u>

#### 3. CALL (765-482-1412)

Complete the final step in the application process at the Sheriff's Office within 90 days. Please wait at least 48 hours after your fingerprint session has been completed before contacting the Sheriff's Office The Sheriff's Office facilitated the process for residents to obtain gun permits to legally sell or possess firearms. Constitutional carry went into effect on July 1st, 2022. It allows anyone who is at least 18 years old, that can legally possess a firearm, to carry openly or concealed without a license.

#### **TRAFFIC SAFETY**

The Sheriff's Office in 2023, with funds provided and approved by the County Council, purchased a speed trailer. The trailer is a portable unit that contains a radar detector and is available for deployment anywhere in the county. When we receive several complaints in an area, we will deploy that unit and conduct a speed survey (see sample below). ### GOAL 3

### **Supporting our Employees**

How do you we ensure the future will be successful?

#### WELLNESS PROGRAM

The Support Divisions worked diligently again in 2023 to care for all BCSO employees. These divisions assist our employees in many ways physically, emotionally, and mentally.

#### Chaplains (Spiritual Health)

The BCSO Chaplaincy was led by Joni Scott and has 8 other chaplains in the program. Boone County Sheriff's Chaplaincy is a 501-C-3 not-for-profit, non-denominational faith-based organization aimed at serving public safety personnel, those who work or reside in public safety facilities, as well as all residents of Boone County. Their mission is to serve as a supportive group of qualified ministers and counselors, assisting in matters of personal, marriage, job, spiritual as needed, and to be available to assist during times of emergency.

#### Therapist (Mental Health)

Rachel Hall once again partnered with the Sheriff's Office to help keep our staff mentally healthy by striving to improve our already exceptional ability to be resilient. It is a proactive solution to a complex problem. Deputies, correctional officers, and civilian employees all deal with trauma, which is inflicted upon them from working in the law enforcement realm.

#### Peer Support Team (Mental Health)

As the "Peer Support Team" name implies, team members are NOT mental health experts. Instead, they primarily focus on peer-topeer leadership to help coworkers quickly recover from stress. EVERYONE faces tense and uncertain circumstances, but healthy coping mechanisms are crucial. The team added four new members in 2023.

# THE INTERNATIONAL – ASSOCIATION OF CHIEFS OF POLICE DATA

(Violanti, 2013)

The life expectancy of a police officer is 20 years less than his or her civilian counterpart.

The average age of a law enforcement officer (LEO) who has suffered a heart attack is 49 years, compared to 67 <u>years</u> of age for the general population.

LEOs are 25 times more likely to suffer death and disability from heart disease than from a violent action of a suspect.

Despite this information, many agencies have been slow to develop wellness programs and cardiac <u>screening</u> assessments.

#### **CRISIS INTERVENTION TRAINING**

In 2023, BCSO continued to send deputies to Crisis Intervention Team (CIT) training in pursuit of our goal to have 100% of patrol officers trained in CIT. At the end of 2023, over 90% of all officers assigned to the patrol division had attended the training. Officers receive 40 hours of training in topics such as suicide prevention, de-escalation, psychotic disorders, PTSD, substance abuse disorders, veterans, homelessness, developmental disabilities, autism, and dementia. CIT is a community-based program designed to improve the response to mental health crisis. It focuses on developing collaborative relationships between law enforcement, mental health providers, and individuals impacted by mental illness. As a pre-arrest diversion program, the goals of CIT include increasing safety, decreasing the number of individuals with mental illness entering the criminal justice system, and increasing referrals to mental health services.

#### **TRAINERS**

Skills related to firearms, emergency vehicle operations (EVO), and physical tactics required knowledgeable instructors. The Sheriff's Office strived to utilize seasoned trainers mixed with newer instructors to pass along institutional knowledge. Boone County Sheriff's Office went above and beyond the state mandated training.

#### NATIONAL CORRECTIONAL OFFICERS WEEK



In 1984, Former President Ronald Reagan established National Correctional Officers Week. He saw the need to create a week for correctional officers to thank them for their services and celebrate their contributions to society. Often, they are to make sure the court orders are seen through and implemented. During this week, various U.S. agencies honor correctional officers in our jails, prisons, and community correctional facilities by organizing different programs for them.

#### NATIONAL COMMUNICATIONS WEEK

In 1991 Congress proclaimed the second full week in April to be National Public Safety Telecommunications Week to recognize the importance of those special individuals who coordinate the efforts of police, fire, and EMS workers. Telecommunications Operators are the unsung heroes of public safety.



#### NATIONAL INCIDENT BASED REPORTING SYSTEM (NIBRS)

The federally mandated revised method of counting crime was a complex transition in 2020 & 2021. This was a nationwide, cooperative statistical effort of city, county, state and federal law enforcement agencies, reporting data on offenses reported or known.

#### **DRUG TASK FORCE**

The Hamilton/Boone County Drug Task Force is a partnership of nine law enforcement officers from several agencies (Carmel, Fishers, Hamilton County Sheriff's Department, Lebanon, Zionsville and Whitestown) which stem the flow and distribution of illegal substances into and within the two counties. Through the use of specialized training and technology, the Drug Task Force investigates the illegal trafficking of controlled substances, including, but not limited to, marijuana, heroin, cocaine, methamphetamine, alprazolam, buprenorphine, oxycodone, hydrocodone, MDMA, psilocybin, and synthetic drugs.

The primary mission of the Drug Task Force is to identify and arrest individuals or members of organizations that are selling, delivering, or storing illegal drugs and/or weapons in the jurisdictions of Hamilton and Boone Counties. The Drug Task Force also works to identify property and assets that have been acquired with the proceeds of the sale, delivery, or storage of illegal drugs and/or weapons and submit those items for forfeiture. Accordingly, improving the quality of life for the area's neighborhoods is a key goal.



#### **SPECIAL RESPONSE TEAM (SRT)**

The SRT includes officers and deputies from several agencies (Lebanon, Whitestown, Zionsville, and the Boone County Sheriff's Office). These men and women are specifically trained and equipped to resolve critical incidents that are so hazardous, complex, or unusual that they may exceed the capabilities of first responders or investigators. This includes, but is not limited to, hostage taking, barricaded suspects, snipers, terrorist acts and other high- risk incidents. SRT may also be used to serve high-risk warrants, both search and arrest, where public and officer safety issues necessitate such use.

#### **SPECIALZED K9 UNITS**

The Boone County Sheriff's Office had four unique K-9s throughout the year. These magnificently talented animals include: two bloodhounds, a Dutch Shepherd, and a Belgian Malinois. These K-9s helped our deputies solve crime in 2023, but they also gave a great deal of assistance for nearby agencies.



#### K-9 Chase

Sergeant Ryan Musgrave and K-9 Chase were very active with Search and Rescue in 2023. K9 Chase is a full Bloodhound and has been with us for 5 years. They helped track several missing persons over the years. Sergeant Musgrave does several demonstrations throughout the year. In his off time, Chase enjoys spending time with his family and playtime.



#### K-9 Kylo

Sergeant John Barnes and K-9 Kylo were very active with Search and Rescue in 2023. K9 Kylo is a 3year-old German/Dutch Shepard from Belarus. K9 Kylo is trained in narcotics detection and patrol utility and works alongside Sergeant John Barnes. K9 Kylo was responsible for 31 arrests in 2023 ranging in nature from dealing narcotics to violent assaults. During the summer, K9 Kylo assisted the Boone County Criminal Interdiction Unit and the Zionsville Police Department SAFE Unit in the

location of hundreds of doses of fentanyl being transported through Boone County. In his off time, K9 Kylo enjoys barking at the other dogs in the neighborhood and making new friends.



#### K-9 Justice

Sergeant Travis Sutphin and K-9 Justice were very active with Search and Rescue in 2023. K9 Justice is a 2-year-old full Bloodhound. He is trained to track missing endangered adults, missing juveniles, and criminal suspects. Justice loves going to events, especially the schools where she gets a chance to slobber on as many kids as possible. They helped take several fugitives and narcotics off the street.



#### K-9 Rikko

Deputy Tanner Long and K-9 Rikko were very active in enforcement patrols in 2023. K9 Rikko is a 2year-old full Belgian Malinois. He is trained as a patrol canine in narcotics detection, tracking, apprehension, obedience, handler protection, area searches, and article searches. Rikko was released to begin working on patrol with his handler, Deputy Long in June of 2023. During his time following training, Rikko assisted in several narcotics arrests and civil apprehensions during 37 deployments in 2023 on his night shift patrols along with assisting outside agencies on tracks and searching the jail for any potential contraband. On his days off, Rikko excels at being a couch potato and finding ways to get into mischief with his baby human sibling and the other dogs of the house. They helped take several fugitives and narcotics off the street.



#### K-9 Addy

Administrative Assistant Madyson Portish and K-9 Addy are assigned to the Boone County Sheriff's Office Administration Division. She is a rescue canine that was in the county. She gives comfort to all that interact with her in the office.



#### K-9 Zino

K-9 Zino was officially retired in 2023. He spent most of his career working both on the road and in the school system. Zino is enjoying retirement with the McClaine family.

#### **CASE UNIT**

BCSO once again partnered with the Boone County Child Abuse and Sexual Exploitation Task Force. This specialized unit is affiliated with the federal Internet Crimes Against Children (ICAC) program and includes, Lebanon, Whitestown and Zionsville police agencies, along with the Boone County Prosecutors Office.

The Department of Justice, specifically the Office of Juvenile Justice and Delinquent Prevention, created the ICAC programs in 1998. Since its inception, 61 units have been established across the country. This national network is comprised of more than 4,500 federal, state, and local law enforcement and prosecutorial agencies. They will provide forensic and investigative technical assistance to law enforcement and prosecutors as well as educational information to parents, educators and others concerned with child victimization.

#### **VOLUNTEERS**

Bob Craig led the Reserve Division in 2023. This group consisted of 5 deputies (2 Patrol, 3 Auxiliary). They were required to work a minimum of 192 hours annually (16 hours per month). They volunteered a total of 8,126 hours for the citizens of Boone County in 2023.

In addition to their patrol responsibilities, they provided security at numerous special events. They also worked at the Boone County 4H Fair, Thorntown Festival of the Turning Leaves Festival, Lebanon Back to the Fifties, Zionsville Fall Festival, Mischief on Meridian, Lebanon Christmas Parade, and Thanksgiving meal delivery.

#### **DIVISION FINANCIAL PLANS**

Each division organized economic information based on their unique needs. This inversion gave responsibility and decision-making authority back to lower levels within the organization.



In 2023, the Boone County Jail recouped over \$60,560 thousand dollars from housing the state's level 6 felon offenders. This was due to the restructured Indiana Code which required county jails to absorb additional low-level security inmates.

#### **EXECUTIVES AND COUNTY COUNCIL**



Through careful planning and work with our county council, the following items were approved: additional SRO for the school systems, more vehicles for our fleet, and competitive pay for our employees. We meet regularly with council members to make the most efficient fiscal decisions for the tax payers

#### **MERIT BOARD**

The merit board is a civilian board with 2 members elected by the deputies and 3 members appointed by the Sheriff. This board oversees the merit deputy pension fund, approves the Sheriff's hiring and promotion process for merit employees, helps prepare a list of qualified merit applicants, and acts as a discipline board for merit employees who may receive discipline more severe than a 15-day suspension. They play a very important role in the merit system at the Sheriff's Office.





#### **TAX WARRANTS**

The Sheriff's Office is tasked with assisting in the collection of monies owed to the Indiana Department of Revenue. These tax warrants are a chance to make voluntary restitution for taxes owed. The Sheriff's Office partnered with Liberman Technologies to help process tax warrants. A few benefits include payments at the push of a button, faster response time, and a better internet transaction process.

#### **COMMISSARY**

We have expanded our jail commissary to bring in additional income to fund programming for inmates. Most of our programs were paid for by the inmates and community partners, instead of using taxpayer monies.

#### **SHERIFFS SALE**

Sheriff property sales are held the first Thursday of the month at 10:00 AM at the Boone County Fairgrounds, Annex Building. Located at 1300 E. 100 S., Lebanon, IN 46052, except for December, which there will not be a sale.
